## VETERINARY EXAMINATION FOR DYNAMIC SYNDICATIONS

At the request of Dynamic Syndications, pre-sale veterinary examinations were conducted on 122 of the 888 catalogued lots with 86 lots proceeding to have their X-Rays evaluated. One of these was **Lot 276, EXTREME CHOICE ex ENCOSTA JEWEL, 2018 bay yearling filly**, brands as described in the 2020 Magic Millions Yearling Sales Catalogue. This was carried out at the Magic Millions Sale Complex, Bundall QLD, on the 7<sup>th</sup> January 2020, prior to the commencement of the Magic Millions sale.

### Clinical Examination:

A well conformed individual presented in excellent condition. She is athletic with a deep girth and good length of rein. She stands over good ground. The filly is still immature and will develop further. She is a horse that presents as suited to a 2yo programme. All clinical parameters were found to be within normal limits. She was examined in hand and was found to be free moving. Stethoscope examination of heartbeat was normal. There was no clinical evidence of wear or injury to extremities.

### Radiographic Examination:

Pre-sale there was a full set of radiographs available for inspection in the repository at the Magic Millions Complex. Upon examination, they were considered **low risk** and there were no radiographic findings of any significance noted.

### Endoscopic Examination:

Post sale the upper respiratory tract was examined endoscopically, and the larynx and pharynx were found to be normal in appearance and function.

### Conclusion:

In my opinion, at the time of this examination, **Lot 276, EXTREME CHOICE ex ENCOSTA JEWEL, 2018 bay yearling filly**, is in so far as can be determined from the examination conducted, suitable for racing and public syndication and as such, is therefore suitable for all risk mortality insurance cover. I confirm that I advised Dynamic Syndications that in my opinion this lot was suitable for purchase.

## VETERINARY EXAMINATION

At the request of Dynamic Syndications the 2018 Extreme Choice ex Encosta Jewel filly was examined at Bimbadeen Park, Teresa Park, NSW on Wednesday 10th June 2020.

### Identification:

M/C 985100012151984

### History:

This filly had a clean bill of health and was noted to have been well conformed when purchased at the Magic Millions Gold Coast Sale January 2020.

This filly was reported to have developed splints on the inside of both her fore limbs.

### Clinical Examination:

The filly was noted to have large exostosis on the medial aspect mid cannon both forelimbs.

The filly has good conformation and this would not be considered a predisposition to the formation of the bilateral medial splint formation.



As can be seen from the above photograph the filly has developed large ossified callus on both medial cannon bones.

**Radiographic Examination:**

The MCII (medial splint bone) on both fore limbs have sustained fractures mid body. These unstable fractures have resulted in large callus formation around the fracture sites in the healing process.

Note below radiographs of both medial splint bones (MCII) and associated callus formation.

**Treatment:**

The recommended treatment for this condition is removal of the distal portion of both splint bones above the fracture line. The rehabilitation period post surgery is 4 to six months. The prognosis for this horse is fair as the fractures are below the upper third. If this horse is to be syndicated in the future the surgical intervention would need to be disclosed.

**Conclusion:**

All injuries and abnormalities need to be fully disclosed on a veterinary certificate which is a requirement for the product disclosure statement necessary to syndicate a horse under the requirements of Racing Australia. As such I am unable to provide Dynamic Syndications with a veterinary certificate that would enable syndication of this filly.

Encosta Jewel 18 was examined on July 1st 2020 at Bimbadeen Park. Both forelimbs have large exostoses or splints on the inside of the legs. Although there was no reaction to palpation on the outside of the splints, when I palpated the inside area close to the suspensory ligaments there was some pain noted, both on the bone and the ligaments. I've recommended applying DMSO twice daily. I am happy for the horse to go into a small yard. I will review and ultrasound the front legs in 3 weeks to determine if surgery is recommended.

## VETERINARY REPORT

Encosta Jewel 18 was presented to Agnes Banks Equine Clinic on July 27<sup>th</sup> 2020 for surgery to remove two large medial exostoses on both front legs. Under general anaesthesia the splint bones were removed from the buttons to above the exostosis. In the right front leg a considerable part of the new bone was associated with cannon bone (versus the medial splint bone) and wrapped around the back of the cannon bone.

The filly was treated with penicillin and gentamicin as well as phenylbutazone. The bandages were changed on July 31<sup>st</sup> and August 3<sup>rd</sup> and the incisions were dry with mild thickening over the surgery sites (which is to be expected).

### AT HOME CARE:

1. Please give 5 ml phenylbutazone once daily for 5 days
2. Please keep confined to a box for 3 weeks.
3. The bandages should be changed every 3-5 days (or as needed) for the next 3 weeks.  
Christine will do the next bandage change at Bimbadeen on August 5<sup>th</sup>. The sutures should be removed on August 12<sup>th</sup>
4. Please monitor for any lameness, any increased swelling or any discharge from the surgery sites.
5. I will plan to review the filly before she is turned into a larger area.

Encosta Jewel 18 was reviewed at Bimbadeen Park on September 30<sup>th</sup> 2020. There were some mild abrasions over the cannon region of both front legs. The front suspensory ligaments palpated without pain. No lameness was seen at a trot in a straight line. Ultrasound revealed both front suspensory ligaments appear similar to the previous ultrasound. I consider the horse suitable for racing and am happy for the horse to start some trotting work under saddle. A recheck ultrasound is recommended in 6 weeks.
