For the avoidance of doubt, and of any perceived or potential conflict of interest, I confirm that I was the trainer of African Daisy prior to the sale. I confirm that I advised Dynamic Syndications I would be delighted if the filly returned to me to continue her training.

Further, my business practice is in accordance with the Product Disclosure Statement supplied with this horse.

I also acknowledge that Dynamic Syndications employs Dr. Tim Roberts as their contracted veterinarian. I am aware Dr. Roberts has inspected this horse at the sales prior to purchase, where she passed a physical examination, and the inspection did not reveal any areas of concern. I am also aware the horse passed a post-sale endoscopic evaluation and blood testing and the horse was passed as suitable candidate for syndication for racing purposes.

3. PROPRIETOR'S ADDITIONAL REMUNERATION AND GRATUITIES

1. If the Horse, being an Entire, is sold or retired to stud:
- (a) an additional fee being an amount equal to 5% (plus GST) of the sale price (excluding GST); and
 - (b) one (1) transferable lifetime service right which will entitle the holder of such right to nominate a mare to be provided with a stud service by the Horse during each stud season that the Horse is used to provide stud services commercially, free of any service fee.
2. If the Horse, being other than an Entire to which paragraph 1 applies, is sold while being trained by the Proprietor or within 3 months after ceasing to be trained by the Proprietor, an additional fee being an amount equal to 5% (plus GST) of the sale price (excluding GST).
3. If the horse is sold to continue its racing career whilst being trained by the Proprietor, abroad or locally, an additional fee being an amount equal to 5% (plus GST) of the sale price (excluding GST).

Notes:

- (1) The entitlements of the Proprietor to the additional remuneration and gratuities set out in paragraph 1:
- (2) Will not be conditional upon the Proprietor being the trainer of the Horse at the time of it being sold or retired to stud.
- (3) The entitlements of the Proprietor to the additional remuneration set out in paragraphs 1 and 2 will also apply to the sale of an interest or share in the Horse.
