VETERINARY EXAMINATION FOR DYNAMIC SYNDICATIONS

At the request of Dynamic Syndications, a pre-sale veterinary examination was conducted on **Lot 27 AHSO, a 3yo Bay Gelding by SEBRING x QUENCH THE THIRST**, brands Capital N over bar nr shoulder, 77 over 7 off shoulder, as described in the 2021 Inglis Online 24 February Sale. This examination was carried out at Wild Oaks Spelling Farm, The Oaks NSW, on the afternoon of Tuesday 23rd February 2021, prior to the commencement of this sale the following day.

Clinical Examination:

This gelding was returned to the spelling paddock after his race on 9th February 21, waiting for the sale to commence. This quality individual is strong and athletic with good scope and was presented in excellent condition. He has a good length of rein and deep girth. He stands over good ground. All clinical parameters were found to be within normal limits. He was examined in hand and was found to be free moving. Stethoscope examination of heartbeat was normal. There was no clinical evidence of injury or wear to his extremities.

Radiographic Examination:

Being within the racehorse section of the sale, there is no requirement to have x-rays supplied by the vendor. Therefore, no x-rays were available to be reviewed.

Endoscopic Examination:

The upper respiratory tract was examined endoscopically and found to have normal anatomy. Laryngeal function was normal, symmetrical and synchronous; grade 1 (Lane scale).

Conclusion:

In my opinion, at the time of this examination, **Lot 27 AHSO, a 3yo Bay Gelding, SEBRING x QUENCH THE THIRST**, is in so far as can be determined from the examination conducted, suitable for racing and public syndication and as such, is therefore suitable for all risk mortality insurance cover.

I confirm that I advised Dynamic Syndications that in my opinion this lot was suitable for their purchase.
