## VETERINARY EXAMINATION FOR DYNAMIC SYNDICATIONS

At the request of Dynamic Syndications, our practice was asked to re-examine the **PIERRO ex TIARE, 2019 bay/brown 2yo filly**, brands described as **Vertical line with conjoined Lightning Bolt** nr sh., **14 over 9** off sh., to assess its continued suitability for public syndication. The purpose of the re-examination request was for the promoter to meet ongoing compliance with regulatory requirements by supplying a current veterinary certificate for inclusion with their PDS.

I had previously inspected this horse on behalf of Dynamic Syndications at the 2021 William Inglis Classic Yearling Sale at the Inglis Riverside Stables Sales Complex, Warwick Farm, NSW, on the 5th February 2021, prior to the commencement of the 2021 Inglis Classic sale where a detailed pre-purchase inspection was conducted including a full set of x-rays being read and were considered **low risk**, and an endoscopic evaluation conducted which was **Grade 1** (low risk). I advised my client at the time; in my opinion the filly was suitable for their purchase.

### Clinical Examination:

The re-examination was performed at Bimbadeen Park, 50 Sylvan Rd, Werombi, NSW where the filly has been spelling since 30 June 2021. It was a general health check which included temperature, pulse, respiration, thoracic auscultation, as well as an ophthalmological examination for eyesight, mucous membrane colour, musculature symmetry and basic conformation, where no abnormalities were found.


There was no lameness at the walk and trot in hand. No response to hoof testers was found. On palpation and manipulation of the distal limbs including major joints, no abnormalities were found. The filly had a quiet temperament.

The filly remains a high-quality individual, athletic and free moving. She is well conformed and well balanced. The filly is still immature and will develop further. All clinical parameters were found to be within normal limits. No radiographs, blood tests, drug sampling, ECG or upper respiratory endoscope were performed.

### Conclusion:

In my opinion, as at the **9th AUGUST 2021**, the date of re-examination, the **PIERRO ex TIARE 2019 bay/brown 2yo filly**, is in so far as can be determined from the examination conducted, presents in good health and has passed clinical examination and remains suitable for all risk mortality insurance cover and is suitable for racing and public syndication.

## VETERINARY EXAMINATION FOR DYNAMIC SYNDICATIONS

At the request of Dynamic Syndications, a pre-sale veterinary examination was conducted on **Lot 379 PIERRO ex TIARE, 2019 bay / brown yearling filly**, brands as described in the 2021 William Inglis Classic Yearling Sale Catalogue, was carried out at the Inglis Riverside Stables Sales Complex, Warwick Farm, NSW, on the 5th February 2021, prior to the commencement of the 2021 Inglis Classic sale.

### Clinical Examination:

She is a well conformed, athletic, high quality yearling. A 3yo miler style of individual however she is well developed and appears precocious to be a possible 2yo prospect. She was presented in excellent condition. She has a deep girth and good bone. She has a good action and stands over good ground. The filly is still immature and will develop further. All clinical parameters were found to be within normal limits. She was examined in hand and found to be free moving. Heart auscultation was normal. There was no clinical evidence of wear or injury to extremities.

### Radiographic Examination:

Pre-sale there was a full set of radiographs available for inspection in the repository at the William Inglis Complex. Upon examination, they were considered **low risk**, and there were no findings of any significance noted.

### Endoscopic Examination:

Pre-sale the upper respiratory tract was examined endoscopically, and the filly was passed with the larynx and pharynx found to be **Grade 1**, being normal in appearance and function. Post-sale a secondary endoscopic evaluation was conducted and passed the filly was passed.

### Conclusion:

In my opinion, at the time of this examination, **Lot 379 PIERRO ex TIARE, 2019 bay / brown yearling filly**, is in so far as can be determined from the examination conducted, suitable for racing and public syndication and as such, is therefore suitable for all risk mortality insurance cover. I confirm that I advised Dynamic Syndications that in my opinion this lot was suitable for purchase.
