**Veterinary Report**

I examined the above horse to assess its suitability to syndicate as a race horse.

The examination performed was a general health check which included taking the horse's temperature, checking mucous membrane colour, pulse quality and respiratory system. Cardiac and thoracic auscultation were performed. The eyes were assessed for vision. Musculature symmetry and basic conformation were assessed. No abnormalities were found.

There was no lameness at the walk and trot on a straight line and on a circle. No lameness was noted post flexion of all four limbs. No response to hoof testers was found. On palpation and manipulation of the major joints of the legs, all joints were free of effusion and had a normal range of motion. Soft tissue structures of all four limbs palpated normally.

On endoscopic examination the horse was a grade 1 out of 5 (Normal laryngeal function)

No ancillary procedures such as radiographs, blood tests, drug sampling or ECG were performed.

## VETERINARY EXAMINATION FOR DYNAMIC SYNDICATIONS

At the request of Dynamic Syndications on **Wednesday 25<sup>th</sup> September 2024** our practice was asked to re-examine the **OLE KIRK x MISS SHAMROCK 2022 Chestnut 2YO Filly**, brands described as **Capitals G S over C** nr sh., **31 over 2** off sh., to assess its continued suitability for public syndication or private retention for racing. The purpose of the re-examination request was for the promoter to meet ongoing compliance with regulatory requirements which includes the supply of a current veterinary certificate for inclusion with their PDS.

I had previously inspected this horse on behalf of Dynamic Syndications at Gooree Park Stud, Mudgee NSW, on the 17th July 2023, where a detailed inspection was conducted including a survey set of x-rays which were considered **low risk**. My client declared at that time, for the avoidance of a perceived or potential conflict of interest, that this horse had been bred by Fengood P/L, a company associated with the promoter. The filly was suitable for their public syndication or their retention for racing or syndication.

### Clinical Examination:


This re-examination was performed on the **25th September 2024** at Bimbadeen Park, Werombi, NSW, where the filly has been located since arriving from Gooree Park. The filly had just completed 21 days in re-education training. This was a general health check which included: temperature, pulse, respiration, thoracic auscultation, as well as an ophthalmological examination for eyesight, mucous membrane colour, musculature symmetry and basic conformation. No abnormalities were found. There was no lameness at the walk and trot in hand. No response to hoof testers was found. On palpation and manipulation of the distal limbs including major joints, no abnormalities were found. The filly has a quiet temperament.

The filly remains a free moving, quality individual. She is well balanced, well conformed, with good bone and overall strength. She possesses an athletic conformation. The filly has developed significantly since my previous inspection but is still immature due to her foaling date and will develop further. All clinical parameters were found to be within normal limits. No radiographs, blood tests, drug sampling, ECG or upper respiratory endoscope were performed.

### Conclusion:

In my opinion, as of **25th SEPTEMBER 2024** the date of re-examination, the **OLE KIRK x MISS SHAMROCK 2022 Chestnut 2YO Filly** so far as can be determined from the examination conducted, presents in good health, and passed clinical examination, and remains suitable for all risk mortality insurance cover and is suitable for retention for racing and for public syndication.

## VETERINARY EXAMINATION FOR DYNAMIC SYNDICATIONS

At the request of Dynamic Syndications, for compliance purposes, a veterinary examination was conducted on the **OLE KIRK x MISS SHAMROCK Chestnut Weanling Filly**, brands **Capitals G S over C** nr shoulder, **31** over **2** off shoulder as recorded with the Australian Stud Book. This was carried out at Gooree Park Stud, Mudgee, NSW on Monday **17<sup>th</sup> July 2023**, to ensure the promoter had a current veterinary certificate prior to lodging documents for approval with Racing NSW as lead regulator. For the avoidance of a perceived or potential conflict of interest, it is declared that this horse was bred and retained by Fengood P/L, a company associated with the promoter.

### Clinical Examination:

She is a well conformed, quality individual, presented in good condition. She is a strong style of individual, athletic, with conformation that suggests a Spring 3yo who should lengthen to a mile and further. She has a good length of rein and a deep girth. She stands over good ground. The filly is still quite immature as expected for her late foaling date and will develop and strengthen further over the next 6-12 months. All clinical parameters were found to be within normal limits. There was no clinical evidence of wear or injury to extremities. This clinical health check included: temperature, pulse, respiration, thoracic auscultation, an eyesight ophthalmological examination, mucous membrane colour, musculature symmetry and basic conformation was conducted with no abnormalities found.

She was examined in hand and was found to be free moving. There was no lameness at the walk and trot. On palpation and manipulation of the distal limbs including major joints, no abnormalities were found. The filly displays a quiet temperament.

### Radiographic Examination:

A survey set of radiographs were taken by the stud's attending veterinarian Dr David Parry-Okeden B.V.Sc. on 11 July 2023. Upon examination, the X-rays were considered **low risk**, as there were no radiographic findings of any significance noted.

### Conclusion:

In my opinion, at the time of this examination, my overall rating score was a **PASS, 7+**.

**OLE KIRK x MISS SHAMROCK Chestnut Weanling Filly**, is in so far as can be determined from the examination conducted, suitable for racing and public syndication and as such, is therefore suitable for all risk mortality insurance cover. I confirm that I advised Dynamic Syndications that in my opinion this weanling remains suitable for their retention for racing or public syndication.
